Report of the Pastor

"All that you touch you change. All that you change changes you. The only lasting truth is change..." This quote from Octavia Butler seems like a perfect summary of our last year! When I think of all the change we have endured together as a community since October of 2020, I find myself giving thanks to God and to each of you for your faithfulness, hope, flexibility, courage, and creativity. Look at how God has helped us to change, has shaped and reshaped us to meet the needs of our community over the last year. Now imagine all that God might do with us in 2022!

Since January 1st we have changed our entire worshiping format 5 times: Starting with 1) online only, then 2) drive in/online, moving to 3) two abbreviated in person services plus an online service, then 4) one extended in person service plus an online service, and now 5) one in person service which we live stream and record so that people can still watch us later in the week online. Despite all of this change we are gaining new members nearly every month as people find us to be the church community they have been longing for. In all my years in ministry I have never met a congregation more willing to try new things while preserving our worshiping life together, no matter what.

Perhaps the hardest change for us to endure has been the deaths we have experienced as a community. We knew that 2020 and 2021 were hard years, but our All Saints Service and 2021 membership report really show there has been so much death and grief and I want to name that here. These were our friends, our spouses, our beloved family members and while they are now part of the eternal communion of saints, their loss to us will be felt for years to come. And, it is our conviction that death is not our end, that resurrection is our life eternal, and resurrection is exactly what we are living into at Christ Church today.

Resurrection was what our reopening in May felt like. As we gathered once more in our sanctuary, as our food bank and free clothing boutique reopened their doors, it felt as if we had risen from the tomb! Our service ministries are reminding us daily what it means to be people caring for people. Our commitment to the missional needs of our community continues to be one of our defining points, you need only to read over our mission's report to know that Christ is alive here and the Holy Spirit is on the move. Additionally, community organizations like Tucson Community Orchestra, Christian Youth Theater, and the day care Learn to Grow are continuing to use our facility to host events and continue their life changing programs for people of all ages. Our dedicated volunteers have surged back to our bell and choral music program, and our Sunday School volunteers are relaunching our children's ministry in a totally new way. Our outdoor ministry coordinator has been gathering us together in wonderful ways.

And our online classes and gatherings continue to thrive!

The changing demographics of our congregation and our community are our biggest challenge. We are a thriving and active church, though we all remember the days when that meant kids and families, rather than empty nesters and retirees. What does it look like for us to see ourselves as the people God needs at Christ Church, to appreciate who we are now rather than mourn what we are no longer? We have named as one of our greatest challenges "bringing new people to our church, especially families" in this day and age families come in all shapes and sizes, so as we lean into this time of resurrection, we will need to be attentive to how to welcome a family of one right alongside a family of three or four. I believe if we focus on connecting each new visitor to our community of people caring for people, we will continue to grow, and God will help us reach the people God needs us to reach. If we remain attentive to our community and continue to be in dialogue with our neighbors and keep our doors, hearts, and minds open especially in new and creative ways, we will grow.

What comes next for us Christ Church? In the Gospel of Matthew chapter 28 in the days after the resurrection Jesus' disciples came together and he said to them "Go therefore and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, 20 and teaching them to obey everything that I have commanded you. And remember, I am with you always, to the end of the age." In this digital age of church, the world truly is our parish, and our reach can be as global as want to make it. The vision I keep coming back to lives in those words of Jesus Christ – go, make, baptize, teach, and remember – this is the pattern of our ministry in Christ. Now that we can be back out and about in the world let us go, meet others, make friends, share the life changing joy of God, teach and learn, and finally remember always that God is with us...therefore we will not be afraid.

2022 Nominations

Due to the irregular years of 2020 and 2021, pastor Beth requested, and the Covenant Council voted on 11/23/21 to recommend the following to the Christ Church Conference. Therefore, we ask that the Church Conference of Christ Church adopt this nominations report for 2021, and leadership for 2022.

Several ministry teams and work areas, as well as finance and trustees will remain the same other than the changes listed below – with regular rotation of classes to begin in Jan. 2023.

The chairs of Missions and Covenant Council have requested to serve in an interim (one year) capacity.

Due to our current membership, the fact that we only have one pastor, and our budget limitations we recommend the Christ Church Conference elect two lay delegates to Annual Conference, plus an alternate, if we need additional delegates we may hold a special election for that process.

The following training, recruitment, and rotation plan be implemented in 2022 for 2023:

Beginning in the spring of 2022 Christ Church will do education for anyone interested about our ministry areas, leadership positions, as well as some exploration of changing and combining some of our ministry teams with the goal of letting people know what these ministries are and what they do and how folks can get involved. We are hoping this will encourage new people from throughout our congregation to participate in an open nominations and self-nomination process we hope to launch the end in the middle of spring. Our hope is that people will express interest in areas of leadership and service they are passionate about and people in current leadership seeking change can explore new ways of being in service. Then the nominations team will then engage in a recruitment process in August/September of 2022 and report to covenant council and the congregation our progress at the end of September.

Board of Trustees Annual Report

The Board of Trustees is the caretaker of the physical plant of the church. We are responsible for the building upkeep, remodeling, and use of the buildings. We also look at the safety of the the building and property and that they are used safely. The church is incorporated making the board also the Board of Directors of the corporation. From that we are responsible that the church is run as a legal business and that its practices are done in a legal manner.

This past year has been a struggle with the Covid Pandemic. It has required us to limit the use of the buildings to prevent spreading the disease to others around us. A good part of last year, an outdoor parking lot service was provided using a radio broadcast system with microphones and an electronic keyboard.

We have been able to open up some of the in-person services and are now having live services in the Sanctuary with measures in effect to keep social distancing. We have also started live-streaming the service so that the service can be enjoyed at home or on the road. Measures have been taken to ensure fresh air circulation and proper sanitation. Our repaired/ungraded air conditioning system has helped us maintain a comfortable environment.

Many of our air conditioning units are old, so we will be replacing older units as they fail. With limited use of the campus, this has been extended and delayed which has helped our finances. We continue to evaluate areas of need. With the winter and summer rains came some roofing problems. We have now re coated most of the roofs and repaired defective areas to minimize any further leaks and potential damage.

Parking lots and mainline sewer repairs remain on our watch list. We encourage anyone who sees something that needs repair or upgrading to let us know.

Always know that our Trustee meetings are open to all. Please feel free to talk to any of the trustees to let them know what they might have missed. We are from many talents which adds to our ability to make judicious decisions.

SPRC Annual Report

The Staff Parrish Relations Committee (SPRC) has successfully met several challenges during the current year, many arising from the pandemic and two personnel changes.

Choirs Director Hired

The Staff Parrish Relations Committee reviewed the Choir Director job description and made appropriate changes. During the summer, an ad-hoc subcommittee, headed by Diane Wilkinson, included choir members who were SPRC members conducted a search for a choir director. After narrowing the candidates, they conducted interviews via teleconferencing and in-person meetings. Sinamar Respicio was offered the position and accepted; she started on August 16, 2021.

Office Administrator

Catherine Shaw, the office administrator for the last 4 ½ years summitted her resignation effective July 27, 2021. The committee reviewed the job description and made appropriate changes. Pastor Beth headed the search committee since she would be working closely with this person along with other members of the committee. Several candidates were interviewed, mostly by Zoom, and then in person. Skye Zonoozi was offered the position and she accepted.

Pastor

Since Pastor Beth was in her first year of pastoring Christ Church United Methodist, and all of it during the pandemic with a portion of the year under pandemic lockdown, SPRC worked to make the transition as smooth as possible. The church is now open on a limited basis, and names and faces are being matched. It is functioning well, and Pastor Beth's many talents and enthusiasm are appreciated. It is SPRC's recommendation that we retain Pastor Beth as our pastor.

Year-end performance reviews for all staff are underway. Pastor Beth's has been completed.

Missions Annual Report

The Mission's team and the volunteers who support the various projects serving our church and community, give encouragement and inspiration to hundreds of people who come to our campus or whom we serve in off-campus efforts.

CCUM Food Bank: a partner with the Tucson Community Food Bank.

The CCUM Food Bank reopened May 11, 2021 after being closed due to Covid. We are open 3 days a week.

So far in 2021 the CCUM Food Bank has distributed 387 food bags to households, assisting 883 people. Also, 322 households received personal hygiene items and 90 received pet food.

Through a partnership with The Diaper Bank of Southern Arizona, we have distributed 166 packages of diapers.

It has been challenging to reopen but our volunteers are eager to help their community. We will see what 2022 brings!

Clothing Boutique

After being closed for 14 months due to the Pandemic, the FREE Clothing Boutique reopened May 4, 2021 observing all Covid procedures and policies. We are open Tuesday and Wednesday mornings from 9:30-11:30. We have 10 volunteers.

The Clothing Boutique provides clean, gently used clothing from infants through adults as well as linens and small household items. All items are free.

We have a diverse population of shoppers: young families, homeless, those seeking work related/interview clothing, marginalized, and those who prefer to recycle/repurpose clothing.

As of October 20th, we've had 568 shoppers, providing clothes for over 800 family members. Our number of shoppers varies, but we often have 15-20 or more shoppers daily. 25% are first time shoppers with us which means we are reaching a wider community. We are most grateful for your continued support of this outreach ministry.

Food for Life

The Food for Life Program is one of the Southern Arizona AIDS Foundation (SAAF) projects which delivers three meals a day to homebound clients who may have trouble preparing meals on their own. The program usually delivers more than 25,000 meals annually. Christ Church has been providing some of the baked goods for these meals since the mid-1990s. A group of 24 from CCUM provided the baked goods for these meals, seven times a year. The baked goods are used to complete the dinner meals for the recipients. The bakers supported the Food for Life program by providing baked goods for the Southern Arizona AIDS Foundation on February 2, March 23, May 11, June 29, August 10, October 12, and will provide them on December 14, 2021.

Primavera Men's Shelter Dinner Ministry

Through the Covid pandemic, the church has continued to support Primavera financially to assist in feeding the men staying at the shelter. During this time, capacity at the shelter has been limited to 32 guests. The shelter recently allowed groups to begin serving meals in person. This has allowed the ministry team - specifically the Stephen Ministers - to send a group down to serve in late September. We have also resumed shopping for the Primavera ministry, with the kitchen staff at the shelter preparing the meals as before. This will provide us, as people caring for people, with new opportunities to serve those around us.

Asylum Mission

The Asylum Mission assists asylum seekers, most of whom have been targeted for assassination by their governments. Volunteers meet twice a week, Monday and Friday afternoons, with these clients mostly from Africa. The volunteers' tasks include completing asylum applications, work permits, applications for green cards and citizenship, travel documents, and sending for family members, not only for asylees but also for permanent residents and citizens. A major task, and one of the most time-consuming, is helping asylum applicants prepare their narratives, which are the part of their asylum applications in which they tell their personal stories and explain why they qualify for asylum. These take several weeks to complete and may run to 150 pages with supporting documentation. All of this work is in addition to telephone and email contacts. Volunteers are now being swamped with more Africans who are seeking asylum than they can handle expeditiously. Like last year, volunteers help with completing the applications and narratives, making copies of the applications as well as copying documents, photos, and passports. This year the volunteers also found themselves spending more and more time straightening out problems that arise because of the delays and errors that result from the current overload on the whole immigration system. COVID-19 has placed even more challenges to this project, as it has to most groups. We are always in need of additional volunteers.

Mental Health Awareness

CCUM participates in a NAMI (National Alliance on Mentally Illness) program called Faith Net, in which religious settings provide safe, supportive, and caring environments for educational classes. These classes were suspended due to COVID, however some ZOOM classes and ZOOM support sessions are being held. These classes have the goal of informing church members and the community about the realities, issues, and challenges of mental illness. In addition, the Missions Team has also frequently provided flyers and other information about mental health for our church family.

Foster Children and Families

Foster Kids Project: Last year Missions sponsored a COVID version of the Foster Kids' Christmas Party. Instead of an "in-person" get-together and a presentation of gifts, Missions and the congregation joined together to provide the children with gifts or gift cards that were specific to age groups. These items were listed on an Amazon wishlist and church members could order them directly and have them sent to the foster care group we partnered with. This reduced the in-person interactions. Some church members wanted to make a designated donation, which the committee could use as requested by the foster care organizers. We will do a similar program this year.

Interfaith Community Services Partnership (ICS)

CCUM became a partner faith community with Interfaith Community Services in 2016. ICS provides needed social services to CCUM members and those we serve through our existing outreach ministries.

All Church Family Retreat returned to the Southern Arizona Girl Scout Retreat Center after a year's interruption due to Covid-19. Lots of food, lots of crafts and lots of renewal of friendships and fellowshipping took place at this retreat. Although the event lasted only five hours, there was a slice of camping life that everyone took home with them.

We are looking forward to being able to share more activities with our congregation in the new year. Your support of this ministry has enabled us to pursue our mission of bringing people to Christ through the fellowship of camping and outdoor activities.

Stephen Ministry in 2021 has continued to be a valuable resource at CCUM during the Covid 19 pandemic and continues to support our members and families, as well as the Tucson community. We are in constant prayer for our members as we share God's gifts of support and a listening ear through our loving care. We have Stephen Ministry Supervision meetings via Zoom (since the pandemic started) and meet regularly with care receivers mostly by phone. This has enabled us to maintain the required CDC and UMC Covid 19 safety protocols.

The Stephen Ministers are very pleased to have full support from our beloved Pastor Beth. We helped to support the Christ Church drive-in services during the summer as well as the recorded services. This has helped us stay safely connected to our community even through the midst of the raging pandemic.

In addition to providing one-on-one (confidential) care for persons going through one of life's crises by encouraging and walking alongside of them during difficult times, we serve many homebound members each month by visiting and serving them communion when it is safe to do so. We do our best to visit those in hospitals and care homes. We serve grieving families at memorial services and funerals. A series of grief books (over a year's time) is sent to each grieving family on behalf of Christ Church Stephen Ministry.

Our Stephen Ministry started serving dinner again in October at the Primavera Men's Shelter 4 times a year (all the 5th Thursdays). We are also serving in many areas of the church such as the food bank, clothing boutique and on committees.

Two Stephen Ministry Leaders (Gretchen Lofgren and Peggy Scalzo) have moved on to retirement, however Gretchen has agreed to stay on to help with the transition on an indefinite basis. We were happy to get another Stephen Ministry leader when Shawne Sidles joined our church in August of this year. We now have a total of 6 active Stephen Ministers, 2 Stephen

Leaders and 3 who are taking a temporary break. There are numerous Stephen Ministers in the congregation who are not active, but available if needed.

November 14th was Stephen Ministry Sunday at Christ Church, the first in approximately 4 years, and all the Stephen Ministers were happy to carry out the entire Church Service, from Preaching, Ushering, Greeting, and the Stewardship Moment!

We look forward to serving the members of CCUM and the Tucson community for many years to come. We will be continually seeking new Stephen Ministers and Leaders to be trained as God calls them to serve. We listen and care – GOD CURES!

Retired Pastor's Report to the Charge Conference

As a retired member of the California-Nevada Annual Conference, my Charge Conference is Livingston United Methodist Church. My wife and I also attend Christ Church UM in Tucson, Arizona, where we live. My wife has her membership here.

This has been the year of Covid, so many of our church and volunteer activities were canceled or moved to Zoom. We had hoped to go back to North Carolina in the summer of 2020, but that was also canceled. My Rotary Club has helped with the food distribution to families in the Sunnyside School District in a Hispanic section of Tucson. We've enjoyed packing vegetables for a good cause.

In 2021, I've continued to lead the Adult Sunday School Class and the Men's Group weekly on Zoom. They have been vital groups, and I've enjoyed doing that. When our pastor contracted Covid, I helped fill in by phoning a number of people on the prayer list. I was working on a sermon on the call of Samuel for the Congregational Church in Martinez, CA, when she called asking me on Thursday, asking if I could record a sermon for her on Friday. I recorded that sermon and then used it for the church in Martinez the next Sunday!

In the Spring, I was contacted by the pastor of the Vail Campus, a new church start here in Tucson, to see if I could do two sermons in April and May on Nehemiah. I'd never preached on Nehemiah in 43 years in the ministry. They were meeting in a school auditorium sitting at tables spread out across the floor. I enjoyed that very much.

Then in May we drove to Winston-Salem, North Carolina, to spend the summer with our family there. We saw Sarah, our granddaughter turn 18, graduate from High School, get her driver's license and start her Freshman year the University of North Carolina at Charlotte, where she is studying engineering like her father. Joy, our older granddaughter I working in a restaurant and continues to study art at the University of North Carolina at Greensboro. People at Livingston will remember them visiting us when we were there.

We attended Mt. Carmel UMC in Winston-Salem when we were there before, so we started back there. I was invited to preach twice that summer, using... you guessed it... Nehemiah! I also helped lead a Bible study on Moses using Adam Hamilton's book. As we had done Exodus in the Adult Class at Christ Church, I was well prepared!

They were also investigating a program called Celebrate Recovery, which I enjoyed learning about. It is an exciting ministry to people in recovery from many problems, not just alcohol or drugs.

We continued with many Christ Church activities on Zoom as well as Rotary in Tucson while we were in North Carolina. Elizabeth had been diagnosed with mild Parkinson's in March, but we were able to make the drive anyway. While there I had a TIA (a small stroke) which resulted in a number of medical tests. I did not have another one, but we are doing tests with my doctors now in Tucson to prevent another one from happening. Elizabeth walks most mornings for exercise. I had a borrowed bike in Winston-Salem which I could ride many mornings there. I've continued that since coming home.

Our church has gone to in person services and Elizabeth has gone back to choir. We plan to attend the in person services. We have given up the Monitoring Program at our park as we need to slow down. I've given up Rotary, but I'm hoping to stay involved in the Toy Train Museum, which is now opening up again.

We don't know what the future holds, but we hope to stay active. Right now we are planning to go back to North Carolina next summer.

We will need to take it a day at a time, leaving the future to God.
