Report of the Pastor

The State of the church:

Christ Church remains a community blessed to be a blessing! Our worship services reach an average of 150 people at home, online and in person each week, plus dozens of views during the week on YouTube. Our re-imagined children's ministry program averages six children on our Children's Sundays. Our adult education and spiritual care programs reach more than 50 households a week. We have dozens of choristers and ringers. Our food bank partnership assisted 1,384 families in our area and hundreds of people were served by our clothing boutique, blessing bag ministries, partnerships with Food for Life and Primavera, and other mission ministries. Groups like Women at the Well, Helping Hands, and United Women in Faith keep people connected and cared for, and dozens of community groups like Learning to Grow day care and Christian Youth Theater meet on our campus weekly to serve children and young people.

Whether its outstanding organ music, prayerful worship, or traditional hymns with all the verses sung, we are a place people find what they are looking for in worship. On average, two new people come to our worship services every week. About 25% of these visitors become active participants in the life of our church. We are a vital church because, most importantly, people are finding connection to God, to one another, to the practices of faith that give them meaning, we are connecting with other people in service and mission.

For 20 years, Christ Church has named reaching families with children as its mission. Unfortunately, this remains an area of non-growth. So what do we do when our reality does not meet our expectations? Perhaps it is time for the church to allow God to change our vision and embrace those new folks who are coming. Perhaps it is time for us to celebrate our age and wisdom and live in the truth that we are reaching new people!

Getting older is not for the faint of heart, all of us know that. It takes courage and boldness, commitment and wisdom to deal with all of the challenges that come with age. Our church is getting older, the buildings are taking more care than they used to, and things are breaking down. Nothing is as easy as it was, but God continues to use us to reach new people, to serve our community, to love our neighbors, and to celebrate Christ! This is what it means to be people caring for people!

Christ Church continues to be a church that is living and breathing, stretching and growing, learning and acting out of grace and compassion. What greater testament could there be to God's



Board of Trustees Annual Report

September 2022

It has been a busy year for the Board of Trustees dealing with a variety of Campus issues, updates, and remodeling. I have highlighted our major improvements below:

- **Repaired, tarred, and re-coated all Church roofs for the next 5 years
- **Remodeled Fellowship Hall Women's bathroom and surrounding area rooms due to plumbing issues, tile, drywall, fixtures, paint, etc...
 - **Upgraded/installed plumbing clean outs on South line and Chain scrub/jet scrub cleaned all lines
 - **Patched and re-coated entire Church asphalt parking lot and all surrounding roadways by contractor
 - **Memorial Garden re-rocking, landscaping, and planting of new Biblical foliage
- **Insurance company inspection resulting in 12 point inspection update and documented repair completion using licensed contractors and including submitted operational emergency plan
- **Painting, repairs, general modifications/clean up following our annual Trustees Campus Walkthrough of minor issues and safety concerns...
 - **Landscaping grass, trees, tree removal on entire campus

PENDING AND SCHEDULED IMPROVEMENTS:

- **Re-rocking and improved landscaping of the Campus interior courtyard and new butterfly garden 9-10-22
 - **Large new commercial canopy installations for the playground area, November 2022
- **Repainting, new flooring, and new carpeting of multiple classrooms for the Learning to Grow School onsite program, October 2022

Treasurer's Report

Christ Church United Methodist is in a good position even though 2022 has been challenging.

As of August 31,

- our pledged giving is lagging behind but that is not unusual for this time of year;
 - we are approximately \$17,500 behind in church income;
 - our bills are all paid
 - the apportionments are current; and
- designation funds have allowed us to maintain the church property by resealing the parking lot, recoating the roofs, and purchasing new air conditioners as necessary;

Our investments that are in Westpath, a part of the Desert Southwest United Methodist Foundation, have decreased in value by 17% since the beginning of the year. This decrease is better than the decrease in the overall market (-20% to -30% by most indicators).

We have been able to maintain our financial position due to careful spending by our committees and groups. Our ministries are in part funded by designated funds and are going strong.

Our continuing vision of updating the Fellowship Hall kitchen still remains. A new updated kitchen would bring us up to date with city codes and open many new possibilities.

We are looking forward to the new year with hope that we can once again open our kitchens for the many ways we use them for fellowship.

Memorial Prayer Garden Annual Report

Founded in 1990, the CCUM Memorial Prayer Garden remains financially independent due to donations. Funding for the Garden is not included in the church budget.

Five plaques have been added to the Memorial Garden since the last annual report: Georgia Love, Doris Wright, Gina Lenz, Charles Rozelle, and Ardith Powell.

As an honor to Ardith Powell for all the lives she blessed over the years through her beautiful poetry, the cost of her plaque and internment of her ashes in the Memorial Garden were paid from Memorial Garden funds.

We approved the purchase of a portable sound system from Garden funds to be used during Memorial Services held in the Garden (and elsewhere on campus); to date it has not been ordered.

Continued thanks to Ron Thompson, (Co-Trustee of the Memorial Garden), for keeping the Garden looking it's best. The Garden has been re-rocked it, cleaned up overall and three biblical plants have been added.

The garden is open every Sunday morning for people to visit, sit and pray. If one wishes to visit during the week, stop by the office to get the combination to the lock.

The lights installed in the garden in 2017 continue to illuminate the garden and the plaque wall. The American Flag continues to fly 24 hours a day/365 days a year.

2022 Report of the Missions Committee

Christ Church has been active in missions and outreach activities since the congregation was organized 75 years ago. The Missions Committee provides support and guidance for the outreach activities that the congregation operates or participates in alongside other organizations. These activities include a Homeless Ministry, partnership with the Community Food Bank, a Clothing Boutique, support of the Primavera Men's Shelter, and Food for Life in partnership with The AIDS Foundation of Southern Arizona. In addition, we assist to a small extent with the Asylum Mission that lost its primary leader a year ago. We have also taken on a program for foster children at Christmas.

All these ministries need more volunteers if they are to remain viable.

Some notable activities over this year have included:

- Assembling and distributing 100 support bags to the homeless people in our area;
- As involving the Outdoor Ministry with the Ishkishita Refugee Network to pick and donate fruit during fruit harvesting season;
 - Serving an average 21 to 23 people at the Clothing Boutique each day twice weekly;
- As a partner of the Food Bank we have offered personal hygiene items, and cleaning supplies; and we have provided diapers to 287 families and pet food to 469 families. (diapers are supplied through our partnership with the Diaper Bank of Southern Arizona.
- Distributing food provided by the Community Food Bank as well as supplemental food articles donated from our church members to approximately 1384 families in our area;
 - Providing about 20 batches of baked dessert goods for AIDS patients six times a year;
- Providing food for 40-100 evening meals to homeless men at the Primavera Men's Shelter each month on the first and fifth Thursdays; and
 - Assembling the documentary resources described below.

The Missions Committee has been developing two resources to introduce the church's mission outreach activities to members and friends of the congregation.

Desert Southwest Conference The United Methodist Church

The first is a written introduction to each active mission. This guide will explain the various mission activities: what they do for the community and how volunteers participate in the mission's work. It will serve as a guide for the operation of the activity for its leaders and participants and an informational resource for all members of the Christ Church community. It needs more work, but we are on the way.

The other project is the creation of catchy audio video presentations introducing each mission to the Church community in order to encourage all members to become involved.

Our biggest need is more volunteers.

Outdoor Ministry Annual Report

Our year was much different than the past several and thus, many activities were allowed, although, with safety protocols still in force.

January – Bike N' Hike along the Pantano Wash with lunch at Jersey Mike's.

February – Frontier Sunday celebrated with a Pie Celebration after church in the Ramada.

March – Bike N' Hike along the Pantano Wash with lunch at Jersey Mike's.

April – Fruit picking with Iskashitaa. Also, movie night.

June – Pool Party.

July – 4th of July Pie Celebration in Ramada.

August – Helped Youth Education at Back to School Pool Party.

September – Movie night on lawn

October – Family Retreat at Girl Scout's Hacienda Retreat Center.

November – Hiking starting at Lowe's location (not firmed at time of writing)

December – Santa Party in conjunction with Education area.

We were very blessed and excited to share these activities with our church and guests this year, and are very grateful for the support our congregation has afforded us so that we may continue the ministry of bringing people to Christ through fellowship of camping and outdoor activities. Although Covid is still lurking, we are hoping to continue our varied and fun Outdoor Ministry activities this next year.
