

State of the Church 2025

Doing ministry is a bit like baking. The ingredients must come together in just the right proportions to create something with the right depth, flavor, and texture. Patience and precision help — but so do creativity and a whole lot of prayer.

This year, God baked something extraordinary in the test kitchen of Christ Church, and I had the privilege of mixing the ingredients.

Celebrations:

Fifteen new people asked to join the church this year — meaning we kept pace with our losses through death and transfers. We also celebrated our first confirmation graduate in seven years as we welcomed Juan Jimenez as a confirmed member of Christ Church. Every week our list of committed participants who are active, but not members, continues to grow as new visitors become regular attenders. God is shaking things up!

In December of 2024, at 83 years old, Audrey Ricker came to me and asked if she could teach her first Bible study on Zoom. In January we launched her new class – reading the bible together! While she passed away just a few weeks into her new program, her courage, boldness, and spirit of adventure continue to inspire us. What new thing might God be calling you to try this year?

Rev. Ed Denham stepped into teaching adult education during the weekdays, and his class on Revelation brought new people into our adult education program. Speaking of education, the facilitators of Room 4U Sunday School decided to revamp their program and offer our first-ever hybrid online and in person class at Christ Church! They met throughout the summer to update their format and reimagine how their class might carry on Ed Murray, Rev. Bob Kuyper, and Jack Olwine's legacy while better meeting the needs of participants and their own goals as teachers. We are fulfilling the great commission as Jesus said – go and teach!

Our Children's Ministry continues to offer programming on the first Sunday of each month and to host special events around Christmas and Easter. Our partnership ministry with Saint Paul's and Desert Skies continues to provide Christ Church youth with an outstanding program of fellowship, education, and discipleship formation — thanks to the excellent work of Luis Ortiz. We have also continued partnering with Saint Paul's to offer different worship and outreach services between

our two locations, meeting the needs of diverse ages and communities. What an answer to prayer.

Prayer has been a focus this last year as our Shepherd program continues to engage people in phone calls and connection once a month. Our Stephen Ministry has been imagining where it might grow next and has launched our Sweet Hour of Prayer on the second Tuesday of every month, so that we — as a people who care together — might also lift up prayer together. Hope to see you there.

Our leadership invited the church into the process of discerning and crafting a statement that captures God's vision for who we are as a congregation in the United Methodist Church and our mission as People Caring for People. We are excited to see how God will grow us in this work.

Challenges:

As any of us who've aged know, time brings both wisdom and wear — and our buildings are no exception. One of our major challenges this year was the loss of our insurance through the conference group policy. From January to April, each month we paid nearly four times our historical rate to keep coverage, which created a significant financial strain. As a result, we were unable to keep up with our apportionment payments and are currently six months behind on that obligation.

We've also faced ongoing security challenges, with small and medium-sized acts of vandalism occurring regularly on our campus. Our irrigation system had to be completely replaced this year — there was nothing left to patch.

Meanwhile, the demand for our food bank continues to grow even as resources shrink. Every day, people come to our doors who cannot pay their rent, who have suffered unimaginable loss, who are dealing with the messiness of life, and who are looking for a word of Good News.

And while we aren't perfect, we know that God is at work. As one Google reviewer wrote, "You guys saved me."

Lay Leader Report

I am going to share with you some plans for Christ Church that will happen over the next year. Back in September, Covenant Council voted to proceed with a period of discernment to explore the Simplified Accountable Structure (SAS) as a possible structure change for Christ Church. The SAS involves streamlining our current committee-based system into one comprehensive structure that manages the administrative work of the church. Specifically, the four administrative committees: Trustees, Finance, Staff-Parish Relations Committee (SPRC), and Covenant Council, would be combined into one unified Leadership Board. There would still be a separate Nominations committee and of course all our other missions and ministries would continue as well.

Why would we consider this change? Well, the SAS is intriguing because it is a mission-focused structure. Pastor Beth recently guided us through an enlightening all-church visioning process, and we are about to adopt our new mission and vision statements today. And so, the next step for us as a church will be to actively live into our mission and vision.

Simplifying a church's structure to a model such as the SAS can help shift more time, energy, and resources into ministry and fewer resources used in administration. As a result, churches who transition to the SAS model can release more people into ministry to reach people for Jesus Christ, all while being more efficient in how they take care of the business of the church. Ministries can flourish when the church structure is simplified. So, to enhance our missional effectiveness, a change in church structure could be beneficial—but we, as an entire church, will decide that together.

On the other hand, if you compare our current committee-based structure, which is also a valid way of doing the work, that structure focuses a lot more on filling committee positions, specifically those administrative positions first, and then leaving a smaller number of people available or willing to do the ministries of the church—and that can eventually wear down church leaders. In an era of our church in which we are comprised largely of an older (and wiser!) congregation, it might be worthwhile to consider ways we can be nimbler and more efficient with how we do the business of the church.

Ultimately though, simplifying a church's structure is a big decision and we should not take this decision lightly. Our plan is to take the next 6 to 8 months to learn about the Simplified Accountable Structure with the entire church, to fully educate ourselves, and to discern if this will

be a good option for us in the future. After this discernment period, once we have been adequately educated, we will then have a special Church Conference where the church would vote on the SAS and decide officially if we'd like to transition to this model. That vote would ideally be before summertime next year, so that Nominations Committee would have plenty of time to discern and recruit people onto the Leadership Board (if we decide to go that route). So then, at our Church Conference next year in 2026 we would potentially be voting on the slate of people for the new Leadership Board that would start in January 2027.

The discernment period we are about to embark upon is largely educational as well as a time of exploration. We will be assigned a SAS coach who will help facilitate and guide our discernment period so that we can be fully educated about this structure. There will be multiple group learning sessions about the SAS where we will learn how this structure works, how it is implemented, what the Leadership Board is responsible for, we will learn about accountable leadership, how the board meetings are structured, and how information will be shared with the congregation regarding the work done by the Leadership Board. Everyone will have opportunities to learn, ask questions and have conversations about the simplified accountable structure. I would encourage anyone with questions about any of this to talk to myself, Pastor Beth, or even Rev. Javier who has his own unique perspective working with churches who have explored this structure and have made the transition. My hope is that we would enter this period of discernment together with a little bit of curiosity and a lot of grace. But please know, more information will be forthcoming, so stay tuned.

Simplified Accountability Structure Overview

What is it?

- SAS is a simplified church structure in which the four administrative committees (Trustees, Finance, SPRC, Covenant Council) are replaced by one Leadership Board, consisting of nine people serving three-year terms.

Why do we want to consider this? What are the benefits?

- SAS removes bottlenecks in decision-making process (i.e. time, energy, resources, multiple committees, silos, disjointed focus and priorities).
- SAS has a missional focus— the Leadership Board aligns church resources to the mission and vision.
- Less meetings and more people are released and available for ministry.
- SAS is adaptable to our church's unique, changing landscape. Systems, procedures, and policies in place are flexible and adaptable.

What's next?

- The Discernment Phase—We will spend the next 6-8 months learning about the SAS. There will be layers of conversations and communications for all.

- Sometime around May we will have a special Church Conference to vote whether we want to transition to the SAS model.

After we vote then what?

- If we vote in favor of transitioning to the SAS, the Nominations Committee will begin discerning and recruiting people to make up the 9-person Leadership Board.
- If we decide not to transition to the SAS and instead remain with our current committeebased structure, the Nominations Committee will begin discerning and recruiting people to fill all the committee positions as usual.
- For our Church Conference in Fall 2026 we will be voting to affirm either:
 - 1) the people making up our new Leadership Board (if we transition to SAS)
 -- OR--
 - 2) the people comprising all our usual committees

Leadership Team/Covenant Council Annual Report 2025

Your Covenant Council consists of twenty-one members plus Pastor Beth Rambikur. There are eleven ministry areas represented and ten members at large. We held committee meetings by zoom in January, February, March, April, July, August and September. Each meeting begins with a devotion and prayer. We then have committee reports as needed from Finance, Trustees, SPRC, Outdoor Ministries, and any others that have business to present.

We hosted three potlucks this year, along with Outdoor Ministries. Our first potluck was held on Frontier Sunday on February 23. We held the next one on May 25. The third potluck was held in conjunction with the Clothing Boutique open house on September 28. All three potlucks were well attended. Everyone enjoyed the time for fellowship.

In May we held an in person retreat in Social Hall where we developed a proposed mission statement and vision statement, along with a list of values. This was followed by three listening sessions in August where we received input from the congregation. Using that input, we have proposed the following statements to be submitted to the all church conference for approval.

Vision, Mission, and Values Statements:

Proposed Amended Vision Statement: To welcome and serve all with courage following Christ's example through compassion, fellowship, and our faith.

Proposed Amended Mission Statement: We are a welcoming, inclusive faith community where all are invited to grow in faith and participate in ministry to the world.

Proposed Amended Values: As a United Methodist Church, we value: Grace/Love, Welcoming, Joyful Praise, Service, Openness, Prayerfulness, Selflessness, Honesty, Acceptance, and Spirit Filled Discipleship.

Motto: People Caring for People

Statement of who we are:

As a congregation of the United Methodist Church, we follow in the footsteps of Christ by engaging in ministry through: Missions, Music, Education, Prayer, Fellowship, Worship and Acts of Service.

If these statements are approved, this is what will appear on our website and any advertising that we distribute.

Next year we have plans to explore the Simplified Accountable Structure. This would streamline the four administrative boards of Covenant Council, Finance, Trustees, and SPRC into a single board consisting of nine members. If approved, there will be a period of several months of learning about this structure and discerning it's fit for our congregation. The entire congregation will be invited to participate in this learning process. This new structure would not be adopted until after the learning process and a time of discernment by the congregation. It must be voted on by the congregation before it can be adopted.

Covenant Council members work to represent the congregation in planning for the future of Christ Church. We gladly accept your feedback and recommendations on what you would like to see for our church. We want to make sure that we live into our vision statement, mission statement, values, and motto. It takes everyone to help carry out the mission of the church.

Shared Youth Ministry

Shared Youth Ministry- Church Conference Report – 10/23/25 St. Paul's UMC • Desert Skies UMC • Christ Church UM

Why do we exist?

We help students (grades 6–12) belong, believe, and serve each week. We do this as a weekly, intergenerational ministry that invests in students spiritually and socially, with real belonging, simple faith steps, and fun.

July-October briefly (some highlights):

We started the new school year with a welcome night with games and street tacos for a mission team from Denver, set top priorities with the Jar of Life, and practiced teamwork with games and an escape room (19 teens). After that, we welcomed new students with peer-led volleyball, built community with old-school games, previewed a Grand Canyon star party for middle school, held a culture and diversity workshop with a 2026 Q&A Service Learning trip, and recently planned a comet-viewing night with telescopes to spark curiosity and learning in partnership with members of Christ Church UM.

What we have built (last 14 months)

Belong: Relationships first

We meet every week consistently, and students feel welcome and seen. They even invited friends and connected with teens from all three churches. Hands-on and off-site activities work best, so we're planning more. Favorites include Camping 101, Round1 bowling, Ace of Escape, cooking together, a Sabino hike, and a pool party at Highland Vista Park. We join district youth events every other month. In the last 14 months, we have had 20+ students involved and six regular adult volunteers.

Believe: Growing in faith.

We restarted Sunday School, adopting the Echo the Story curriculum, with simple, creative writing and talk-based learning. We add short devotions and reflections at most gatherings. Last spring, we had five confirmations (including one baptism): St. Paul's (3), Christ Church (1), Desert Skies (1).

Serve: Love in action.

We consistently serve at Fellowship Square, visiting and interacting with our "adopted grandparent". We join community projects like Gospel Rescue Mission and Community Gardens of Tucson. These three organizations are now regular partners in our planning. So far, students are forming friendships, having fun, (re) learning stories of the Bible, and serving together.

What are we doing and planning for this school year?

Weekly gatherings mix fun, faith talks, and service; unplugged games night, a monthly large-group Echo the Story, first steps in Culture & Diversity, movie/community nights, and a hands-on service day (community garden in Vail). Intergenerational moments continue (Advent

visit to Fellowship Square, music leadership chances, and a "Think Tank" with our pastors on Nov 16).

Where we are going (near future and next year)

Keep the weekly rhythm steady, keep Echo the Story simple, and stay local (and internationally), hands-on, and repeatable. We will keep it simple weekly, grow intergenerational moments, and invite 2–3 new Sunday School volunteers (would you join us?). Summer 2026

- <u>Domestic Fun Trip</u> (mainly for middle schoolers) Around the Grand Canyon to build friendships and service, especially for new students (with a science and teamwork approach).
- <u>International Mission & Service-Learning Trip (HS)</u>- Honduras: With partners we know and trust. Planning, timeline, and fundraising plan are already underway. Work on 2026 trips has begun (parents Q&A, first fundraising event in November).

Why does our Shared Youth Ministry matter?

- For students: They have a real place to belong, ask honest questions, and practice faith now.
- For the church: The three-church partnership is working; shared people, spaces, and momentum produce steady participation, service habits, and confirmations (following roster in fall 2026).

- Champion weekly presence: help us keep a steady weekly rhythm by recommending 1–2 adults (especially for Sunday School).
- Invite families: help us find and invite families with 6th–12th graders.
- Share expertise: suggest two or three adults to help at events or lead a simple workshop.

Finance Committee Annual Report 2025

The finance committee meets monthly via Zoom on the third Tuesday of the month, except for a brief respite in the summer months of June and July. The committee enjoys a good blend of experienced and new members and exhibits a firm hold on the concepts reviewed below.

Book-ended by an opening devotional and closing prayer every meeting, the committee examines a Profit and Loss Statement and a Balance Sheet for important trends. In this way we are able to step in and adjust for any unseen consequences or undesired outcomes, such as running over budget. Ron Thompson updates us regularly on maintenance and repairs of our facilities and grounds and we have recently added a quarterly review of our investment results for endowed funds.

Our two additional significant tasks are the approval of the annual budget and facilitation of the stewardship campaign by providing guidance to Pastor Beth. We also keep track of the annual audit, occurring in late September of 2025 to ascertain that all records are kept in accordance with GAAP, Generally Accepted Accounting Principles.

We have been gratified this year to see pledged giving hold steady and total expenses not exceed budgeted amounts. The August year to date financial statement is included as a supplement to this report.

Last year's unexpected equipment and building repairs have not been repeated, and some adjustments to insurance pay-outs from the previous year have been realized. We are also grateful for the Desert Southwest Conference's intercession in finding new and more affordable insurance for the churches in this conference.

Report of the Board of Trustees

The Methodist Book of Discipline sets out the mission of the Board of Trustees as follows:

"The Board of Trustees of Christ Church United Methodist (CCUM) oversees the tangible assets of CCUM in the furtherance of the missions and objectives of CCUM as set out by the various governing bodies of the congregation.

Tangible assets include real and personal property including buildings and grounds and such assets as furniture, vehicles, and books and records associated with the ministries and operations of CCUM."

During the 12-month period ending October 31, 2025, your Board has served to maintain our property to support all of our community, ministry, and mission operations, and those of our long term tenant and ministry partners: Learning to Grow, Building Communities Foundation, Christian Youth Theater, Duffy Neighborhood Association, Compassionate Friends, Tucson Women's Chorus, and Ferraz Piano Studio. Our regular clients: Tucson Masterworks Chorus, Arizona

Repertory Singers, Desert Voices, Sky Island Highschool, Academy of Tucson, addiction support groups, and the Southern Arizona Association of the Guild of Organists.

These projects include:

- 1) We installed a new AC unit for the clothing boutique area in an effort to replace our aging units with working, more energy efficient systems.
- 2) A new projector and computer system were added to the sanctuary worship technology because the old systems were no longer working.
- 3) We contracted with Complete Landscaping to redo our broken and leaking irrigation across the interior of the campus, including the memorial prayer garden, to be better stewards of our water.
- 4) Thanks to Dave Templin, Dan Able and EC group we are updating our obsolete internet and WIFI infrastructure across the campus. Dave and Dan have run cable to nearly every building on the campus in this process. We hope that this will allow us to offer hybrid church meetings and classes (in person and on zoom), enhance our online worship experience, and create a better more consistent working environment for the office which is completely dependent on the internet to function.
- 5) Members are taking on improvement and care projects: Marie Zoellner who painted the upstairs sanctuary bathroom, Becky Gooding and Joandare Jay who are repairing our 40 year old hymnals, and Freda McCabe and her son who have been washing windows, cleaning sidewalks, and polishing pews, Alan Syers who has been assisting Ron Thompson in repairs and improvement projects, and Ron Thompson who keeps everything working and in good shape
- 6) Contracted Highest Standard, an arborist, to care for our trees.
- 7) Maintaining our various mechanical systems like locks and elevators.
- 8) Resolving plumbing issues across the campus, including replacing faucets and toilets.
- 9) Address safety concerns like lighting, uneven grounds, trespassing and unauthorized use of property space. Ron Thompson serves as our security person with Michael Edwards doing morning rounds.
- 10) Updating our service ministry infrastructure new clothing racks in the clothing boutique, repairs of refrigeration in the food bank. We added new seating areas for the foodbank to help with congestion and crowd control.
- 11) And regular maintenance of the property with a grounds keeper who keeps things trimmed, swept, and weeded.

These projects were done or overseen by Church staff and competent contractors working under the oversight of our staff with the assistance of Trustees. In some instances, Learning to Grow has participated by contributing a portion of the costs. Safety and security is becoming an increasing challenge. The Trustees have considered many options – investing in a campus wide camera system, employing security staff or a contractor, increasing training for volunteers. We would love your input on what you have seen work and or contacts that you might have with security organizations.

Your Trustees are considering the 50 to 60-plus year age of our buildings and grounds, and the steps necessary to maintain them in good condition. Why? To support our mission to live and proclaim the word of God to our community and the world while we do that mission in new and changing ways. The Trustees' conversations have identified two areas where proactive steps can be taken to prolong the useful life and value of our facilities so they can support continuation of the ministries of our congregation and partners in ministry. They are: Replacing or repairing water supply and disposal plumbing to prevent continuing failures as old plumbing continues to fail. Continuing replacement of aging HVAC units as they show signs of failure or failing.

Other major projects in the feature are: Parking lot repair. Continuing to find ecological appropriate solutions to our landscape. Chapel improvements so that it can become a space that can meet the demands of our increasingly busy church campus. Expanding and reorganizing our service ministry space to meet the demands of the hundreds of people we are serving each week. Better lightening in the Narthex/Lobby. Better systems for integrating our online community with our in-person community.

Your Trustees continue to consider options for addressing each of these challenging issues and continue to take immediate steps to address property issues as they occur with the concurrence and support of staff.

Your Trustees will also continue the discussion on ways the congregation can address continuing issues with maintaining the value and utility of our church's buildings and property.

Annual Mission Reports 2025

These reports represent those missions who submitted a publication. Additionally **Helping Hands** and **Women at the Well** provide many forms of support to the congregation and community, impacting hundreds of lives across the year. We provide financial support for the ministries of UMCOR, ICS, and SAWS. Our outreach through **Primavera** and our **Food For Life**ministries help feed people across Tucson.

Christ Church Community Food Bank

The CCUM Food Bank is a partner agency for the Community Food Bank of Southern Arizona and the Arizona Diaper Bank. What makes our Food Bank unique is that in addition to food, we also offer personal hygiene items, diapers, and pet food. Clients tell us over and over the reason why they choose to visit our Food Bank is because of the variety of food and additional items they can get compared to other food bank locations. The variety of food and hygiene items our clients appreciate so much is largely due to the generous donations made by members of CCUM.

This year Christ Church helped us double the number of families we are serving through the diaper bank and period supplies. We hope that the church can help us continue to provide these essential resources.

Sometimes we serve as many as 50 families a day. This year we have served more than 5,000 families, a substantial increase over last year. We cannot provide this level of service to our community without the support of CCUM member donations and volunteers. Thank you CCUM for your contributions to the Food Bank. It makes a difference!

The Clothing Boutique



The Clothing Boutique at Christ Church United Methodist started in 2009 as a lay initiated outreach ministry. It continues to play an important role in this community providing free, clean, gently used clothing to young families, the unhoused, the marginalized, those seeking work related/job interview clothing, the elderly, and those who choose to reuse/repurpose.

This year we have had 2,436 shoppers (710 increase) who have shopped for 5,836 family members (1,387 increase). Most

importantly, our first time shoppers increased to 326. We are open Tuesday and Wednesday mornings from 9:30-11:30. There are 11

CCUM Asylum Mission Report

October 2024—September 2025

We are pleased to be asked to highlight the accomplishments of the Asylum Mission during the past year. We are proud of what we have been able to accomplish this year, especially since we only have two active volunteers, one of whom, Ann Brittain, has been coping with a serious illness since April, and we are pleasantly surprised to find that we are willing and able to continue for another year.*

In addition, we have had excellent assistance in our work from a number of people who previously received help from the Asylum Mission and now want to help others, but they do not wish to be mentioned by name. Many others have helped us as needed, particularly by providing translation and interpreter services and helping others fill out forms. We keep in touch with the volunteers and the people we have previously helped through our WhatsApp group, which is aptly named "CCUM Asylum Mission Family." We all consider ourselves to part of the immigrant family founded by Berta Riley when she started the Asylum Mission almost a quarter century ago.

This year we have helped 146 people (most of whom are from Africa and are currently seeking asylum in the US or have already been granted asylum) with various immigration matters,



including asylum applications, work permits, family reunification applications, green card applications, and citizenship applications, and we have helped them find answers to thousands of questions.

Good Samaritan Group (GSG)

Luke says:

"But a Samaritan while traveling came upon him, and when he saw him he was moved with compassion. He went to him and bandaged his wounds, treating them with oil and wine. Then he put him on his own animal, brought him to an inn, and took care of him. The next day he took out two denarii, gave them to the innkeeper, and said, 'Take care of him, and when I come back, I will repay you whatever more you spend.' Which of these three, do you think, was a neighbor to the man who fell into the hands of the robbers?" He said, "The one who showed him mercy." Jesus said to him, "Go and do likewise."" Figuratively, "Good Samaritans" are persons who go out of their way to perform acts of kindness to others, especially strangers!

The Blessing Bag Ministry started several years ago as a part of the Stephen Ministry to help provide needed items and water to the homeless community around Tucson, Arizona! Initially donations were obtained from the congregation. The Blessing bags were assembled and distributed to homeless individuals in our community. Seeing a need for additional help due to an increase in homelessness in Tucson it was restarted in 2021 as a separate Ministry, and was expanded to help support other areas to help the homeless.

As an example, in 2023 we donated Thumb drives to the Gospel Rescue Mission so that individuals seeking to find jobs and eliminate their homeless situation can store their resumes and edit them.

We had a group of members donate some Bibles to the Gospel Rescue Mission.

The Good Samaritan Group continues to receive overwhelming support from the congregation and clergy of Christ Church.
